# Protocol Following Suspected Lack of Efficacy to an Endectocide

The following document is designed to provide SQPs and advisers with a protocol to work to when there is a report by a farmer that a treatment applied against sheep scab has not been effective (due to poor application and/or suspected resistance) and sheep still appear to be itching / rubbing. The objectives are to:

- Safeguard the welfare of the sheep by ensuring appropriate actions (and treatments if required).
- Avoid over use of treatments, especially of the same active class, by ensuring best practice and veterinary diagnosis are employed.
- Report the suspected lack of efficacy to the Marketing Authorisation Holder (MAH) or VMD at www.gov.uk/report-veterinary-medicine-problem
