What is an AMTRA SQP?

A Suitably Qualified Person (SQP) is a professionally qualified and regulated animal medicines advisor, entitled to prescribe and/or supply certain animal medicines under the Veterinary Medicines Regulations. Your SQP is, quite simply, your animal medicines advisor.

What does your AMTRA SQP need to know?

Whether for livestock, horses or pets, your SQP will need to ask various questions before prescribing or supplying animal medicines. Not only is this a legal requirement, but it also establishes the best course of treatment for your animal.

Your SQP is obliged to ask you, as part of the prescription process, about previous treatments, what the animal had been treated with, and what the treatment was for. They will also need to know about the animal's environment. For example, it is crucial to establish if livestock is kept indoors or out, to understand the regime at an equine yard, or to ascertain whether other pets are also kept at home.

The information your SQP gains from asking these simple questions enables delivery of the most effective treatment. Ultimately this could save you a lot of time and ensure that your animal, flock or herd gets the right treatment to maximise health and profitability.

Why will my AMTRA SQP not give me what I want?

It is the duty of your animal medicines advisor to ensure that the statutory requirements in respect of the prescription and/or supply of certain veterinary medicines are respected. The SQP is responsible for ensuring this, and if the required information is not obtained, it is not possible for the prescription process to be finalised as the legal requirements will not have been met.

What medicines can an AMTRA SQP prescribe and/or supply?

SQPs can prescribe and/or supply a range of veterinary medicines under specific distribution classifications.

These can be broken down into three basic categories:

- medicines for farm animals and horses (POM-VPS)
- medicines for non-food animals and pets (NFA-VPS)
- general sales list medicines (AVM-GSL)

Medicines for farm animals or horses, or POM-VPS medicines, are broadly used to reduce or prevent endemic disease in herds, flocks or individual farm animals or horses. This includes internal and external parasites in farm animals and horses, and some vaccines.

Similarly, NFA-VPS medicines may be routinely used for similar treatments for non-food animals and pets.

In all cases, including the supply of general sales list (AVM-GSL) medicines such as shampoos, the SQP will provide practical advice to permit safe and effective usage.

What is the AMTRA SQP's role?

A key part of the SQPs role is to ensure that you, as the animal owner, are provided with full advice on the choice of medicine and its safe and effective use. This is achieved by understanding the individual circumstances of the animal, considering animal health plans and applying best practice in disease and parasite control strategies.

Playing a vital role in keeping the nation's animals healthy, SQPs increase the accessibility to animal medicines, and provide owners with advice on the safe use of these medicines.

SQPs and AMTRA – qualified and professional services.

Every SQPs holds a professional qualification, and AMTRA (the Animal Medicines Training Regulatory Authority) is appointed by the Defra Secretary of State, under the Veterinary Medicines Regulations, to keep a register of SQPs.

All AMTRA SQPs must pass written exams at Higher Education Level 4, and these exams are based on a syllabus produced by AMTRA and Harper Adams University. Once qualified, AMTRA SQPs are required to undertake AMTRA-accredited continuing professional development (CPD) to remain on the SQP Register, and all AMTRA SQPs must also abide by AMTRA's Code of Practice.
